Terms & Conditions

1. The period of contract will be for a period of one year
2. All taxes and duties are to be shown separately
3. Specify TIN and Service Tax Registration Numbers in the tender
4. Incomplete and unsigned tenders will be rejected
5. PAN card copy should be accompanied by the offer.
6. Contractor shall be solely responsible for filing the appropriate Central/State and local tax forms, including without limitation. Contractor further agrees to provide TKCL with responsible assistance in the event of a government audit. TKCL shall deduct taxes at source (TDS) of responsibility falls to TKCL under any Central/State or local tax laws. TKCL will regularly report amounts paid to contractor by filing required forms to government departments.
7. Proper printed, signed and stamped receipt should be given while accepting each motor for rewinding.
8. Loading & unloading of motors at our works will be arranged by TKCL. Transportation, loading unloading and all other handling at contractor's premises should be done by contractor at his own expenses.
9. Deductions will be made for any improper work or delay
10. All motors should be guaranteed for six months against all sort of winding faults.
11. Work should be started immediately as per the direction of Dy. Manager (Works)/Maintenance Engineer and should be completed within 10 days from the date of receipt of motor.
12. In case of emergency requirement, contractor is bound to do the rewinding work at a shorter time than mentioned in (11) above.
13. In no case motors should be kept in contractors premises for more than 30 days.
14. No enhancement of rate will be entertained during or after the contract period
15. Contractor should not sublet the contract without proper consent from the undersigned.
16. Payment will be made only after satisfactory completion of the work duly certified by the concerned authority.
