- 2. The vehicle should have valid Comprehensive insurance coverage etc. And the Contractor is liable for the remittance of taxes and insurance for the vehicle.
- 3. The Diesel Charges will be given by us after producing the Original Diesel Bills.
- 4. The contractor or the men appointed by him shall be held responsible for any loss or damage for company's property or of the public, if caused by his vehicle or men Also.
- 5. The contract is for a period of one year from the date of issue of Work Order. However, TKCL reserves the right to terminate the contract at any time without assigning any reason, for which no compensation shall be claim/paid. TKCL also reserves the right to extend the contract for further period with the contractor at the same rates, terms and conditions.

- 6. All the expenses related the maintenance of the Car, tax, insurance or any other expenses should be in contractor's account. The contractor shall comply with all statutory rules, Orders of Government, Local Authorities etc.
- 7. In case of any break down of the vehicle, while in Company use, the contractor is responsible to make immediate arrangements for providing alternate vehicle to the Company at his risk and cost. If the contractor fails to arrange alternate arrangements, Company will make alternate arrangements. In such cases, the additional expenses in this regard shall be recovered from the defaulter.
  - 8. Offer should accompany photocopies of the authentic documentary proof of ownership, fitness, remittance of Road Tax, comprehensive insurance coverage, etc of the vehicle intended to provide by the tenderer. However, the successful tenderer should produce the originals of all the above documents for our verification and acceptance before our awarding the contract.
  - 9. All the expenses related to the maintenance of the Car, tax; Insurance or any other expenses should be in contractor's account.
  - 10.
