- 3. The Contractor is liable for giving salary for drivers, Diesel Charges will be given by as after producing the Original Diesel Bills.
- 4. The people who are posted as drivers should have valid License/Badge and all other statutory documents. The drivers must be of good character. Polite and healthy in all respects
- 5. The contractor or the men appointed by him shall be held responsible for any loss or damage for company's property or of the public, if caused by his vehicle or men Also.
- A Log Book issued by the company shall be maintained properly in the vehicle. Kilometer reading shall be entered at the end of every trip/journey and it shall be got signed by the user.
- 7. The contract is for a period of one year from the date of issue of Work Order. However, TKCL reserves the right to terminate the contract at any time without assigning any reason, for which no compensation shall be claim/paid. TKCL also reserves the right to extend the contract for further period with the contractor at the same rates, terms and conditions.
- 8. All the expenses related the maintenance of the Car, driver's salary, tax, insurance or any other expenses should be in contractor's account. The Company shall not accept any liability for labour directly or indirectly employed by the contractor. The Company shall not be liable to pay damages compensation on account of injury, or accidents arising during the course of deployment.
